CIRCULAR 12 OF 2026

Dear Parents

PAYMENT OF SCHOOL FEES

We hereby make a serious and urgent appeal to all parents to honour their financial obligations towards the school. School fees are an essential source of income that enables the school to provide quality education, resources, and an exceptional learning environment for every learner.

Please take note that school fees are strictly payable in advance. This means that parents are already liable for the full year's school fees as of 1 January, although a concession is made to allow the amount to be paid in 11 equal monthly instalments. These monthly payments must please be made on or before the 8th of each month.

If a parent's school fee account is overdue by more than 60 days (2 months), the school reserves the right to take legal action to recover the full outstanding amount for the year. In such cases, parents will also be held responsible for any additional collection costs incurred.

We remind parents that the payment of school fees is a statutory obligation, as outlined in Section 40(1) of the South African Schools Act. Both parents are jointly responsible for the payment of school fees, regardless of their marital status (married, unmarried, or divorced). In the case of non-payment, both parents may be handed over, irrespective of existing maintenance agreements or court orders between the parties.

Parents are responsible for carefully checking their monthly statements and ensuring that all information is correct. If you have not received a statement, it remains your responsibility to pay the school fees and to follow up with the school regarding your account.

We kindly request parents to ensure that the correct reference is used when making school fee payments. The **account reference**, as indicated on your monthly statement, must be used exactly as shown, **for example: 2036 Botha**.

If you have any enquiries regarding your account, please contact us via email at accounts@klofiesdwk.co.za. The D6 platform also provides convenient access to your account, and online payments can be made easily through this system.

We sincerely thank all parents who prioritise their child's school fee payments and make regular contributions. Your support enables the school to provide every learner with the best possible education.

Together with this letter, you will receive the re-enrolment form for 2027. Kindly ensure that it is completed in full and returned no later than **07 August 2026**.

OMSENBRIEF 12 VAN 2026

Geagte Ouers

BETALING VAN SKOOLGELDE

Ons rig hiermee 'n ernstige en dringende beroep op alle ouers om hul finansiële verpligtinge teenoor die skool na te kom. Skoolgeld is 'n noodsaaklike bron van inkomste wat die skool in staat stel om gehalte onderrig, hulpbronne en 'n uitsonderlike leeromgewing vir elke leerder te bied.

Neem asseblief kennis dat skoolgelde streng vooruitbetaalbaar is. Dit beteken dat ouers reeds op 1 Januarie aanspreeklik is vir die volledige jaar se skoolgelde, hoewel 'n toegewing gemaak word om die bedrag in 11 gelyke maandelikse paaiemente af te betaal. Hierdie maandelikse betalings moet asseblief voor of op die 8ste van elke maand gedoen word.

Indien 'n ouer se skoolfondsverpligtinge vir meer as 60 dae (2 maande) agterstallig raak, behou die skool die reg voor om regstappe te neem om die volle uitstaande bedrag vir die jaar in te vorder. In so 'n geval sal ouers ook aanspreeklik wees vir enige addisionele invorderingskoste.

Ons herinner ouers daaraan dat die betaling van skoolgelde 'n statutêre verpligting is, soos vervat in Artikel 40(1) van die Skolewet. Beide ouers is verantwoordelik vir die betaling van skoolgelde ongeag hul huwelikstatus (getroud, ongetroud of geskei). In gevalle van wanbetaling, kan albei ouers oorhandig word, ongeag bestaande onderhoudsreëlings of hofbevele tussen die partye.

Ouers is verantwoordelik om hul maandelikse state noukeurig na te gaan en te verseker dat alle besonderhede korrek is. Indien u nie 'n staat ontvang het nie, bly dit steeds u plig om die skoolfonds te betaal en navraag te doen oor u rekening.

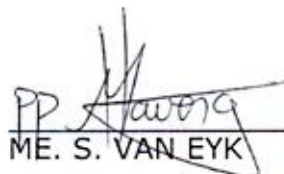
